CANCELLATION: This Agreement cannot be cancelled or modified except in writing by either the Client or DJ. If Client initiates cancellation less than 30 days prior to the event, then Client will be liable for 100% of the entire balance. Only by signing a new Entertainment Agreement with DJ within 14 days of cancellation for a substitute engagement performed in the following 6 months. Rescheduling for events canceled due to inclement weather shall be accommodated without penalty whenever possible. Rescheduled events are subject to availability. **All cancellations must be in writing.**

PROVISIONS: The Client shall ensure that: (1) Performance facility provides DJ with a sturdy table approximately 2x6 feet or 2x8 in an area within 25 feet of performance area. (2) Table shall be within 25 feet of a reliable 15 – ampere circuit. (3) Prong grounded for audio and \ or reliable 20- ampere circuit (3-prong grounded) for lighting effects. (3) Facility is open at least **two hour** prior to scheduled start time; (4) Facility meets all federal and state safety regulations and has an appropriate music licenses and performance permits where applicable; (5) Reasonable steps will be taken to protect VISUAL SOUNDS equipment, personnel, and music, and crowd control will be provided if warranted.(6) For outdoor performances, shelter is provided that completely covers and protects and rain proof. VISUAL SOUND, Equipment from Adverse weather conditions.

Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions. In the event of circumstances deemed by DJ to present real or implied threat of injury or harm to DJ. Equipment, or recordings, them. DJ reserves the right to deny and quest access to recordings or equipment. In the unlikely event the DJ's performance is delayed, liability is limited to providing Client with performance time equal to time lacking. DJ holds all appropriate insurance for its equipment and personnel. Visual Sound can also assign any one Visual Sound DJ for events. Entertainer may take photographs or videotape discreetly at the event. Further, client gives entertainer the right to print, publish, web content and use these freely for promotional purposes only.
